Albert Elvie Hankins & Isabella Jane Goodloe

Albert Elvie Hankins and Isabella Jane Goodloe married on 24 October 1855 in Hopkins County, Kentucky, where they were both born and raised. Baptist minister Rev. P. S. Loving officiated at the ceremony held at Janie's father's home.¹

Albert was born about 1838 to Houston G. Hankins and Mary Weeks.² He was the second of their ten children. Albert's siblings were Mary, Angelina, Josephine, Madison, Eliza, Martha, Linn Boyd, Ella, and James.³

Three of Albert's four great-grandfathers were Revolutionary War veterans who settled in western Kentucky. Houston's grandfathers, John Hankins and Titus Fox become early settlers in Hopkins County after leaving North Carolina. Mary's paternal grandfather, Job Weeks, settled in Livingston County, Kentucky, after serving from New Jersey and migrating to Ohio County, Virginia, following the war. 5

Janie was born on 27 January 1838 to John Emerson Goodloe and Eliza Ann Dobyns.⁶ She was the first of their four children. Her full siblings were Elizabeth, Mary W., and Thomas H.⁷

The Goodloe family lived in the Grapevine area of Hopkins County.⁸ Janie's grandparents, Henry Lewis and Elizabeth Berry Goodloe and Edward and Sarah Mott Dobyns, were also early settlers of Hopkins County along with her great-grandfather John Berry.⁹

By the time Janie turned eleven years old, her mother had died and her father had married Elizabeth Pettus. ¹⁰ Janie gained two half-siblings, Emsley O. and Virginia Goodloe, from her father's second marriage. ¹¹ Elizabeth and Janie apparently had a close relationship. Blurbs from the Earlington newspaper, *The Bee*, in 1903 and 1904, refer to Elizabeth visiting her daughter or Janie visiting her mother in reporting visits between the two. ¹²

Albert and Isabella Jane had four children, all born in Hopkins County. John Houston was born in 1856, Thomas Leander "Lee" in 1858, James W. in 1860, and Mary Madore "Mollie" in 1863. 13

Albert first appeared on the Hopkins County tax list in 1856. He was not over twenty-one years old and owned no land. His only property was a horse valued at \$50.14 Albert is not on the tax list for 1857 or 1859, but he appears in 1858 and consecutively from 1860 through 1864 (excluding the missing 1863 tax book). According to those tax lists and deed records, he never owned land in Hopkins County. In 1858, Albert owned one horse valued at \$50 and was still under twenty-one. Albert, Janie, John, and Lee lived next to Albert's parents in 1860. Albert's occupation was day laborer and his age was twenty-two. The 1860 tax list shows he was over twenty-one and owned one horse (worth \$50), four cattle, 200 bushels of corn, and twelve bushels of wheat. In 1861, he had one horse (worth \$25), one mule (worth \$25), three cattle, and 125 bushels of corn and was enrolled in the militia. In 1862, Albert had one horse (\$20), three cattle, and four hogs. He was enrolled in the militia and had one child between six and eighteen. Albert's last tax list entry, 1864, shows he had two horses (\$50), two cattle, 400 pounds of tobacco, and fifteen bushels of corn. He militia enrollment was active and he still had one child between six and eighteen.

Albert enlisted in the 8th Kentucky Confederate Infantry in October 1861. His muster roll on 1 August 1862 lists him as a 4th Sgt. with Company I, showing him "absent at home in Kentucky without leave." Albert's granddaughter Aggie Hankins Haley passed down a family story that Albert was with a friend in the

company of Confederate deserters, accused of desertion and shot.²³ Elizabeth McCauley Carver (Albert's great-granddaughter) remembered hearing "he got into some trouble and was shot," which goes along with the other story.²⁴

The exact date and cause of Albert's death is unknown, but he died by 1869 when Janie first appeared on the Hopkins County tax list.²⁵ That was five years after Albert's last entry in 1864.²⁶ But since he was missing on two other earlier tax lists when he was alive, it is not possible to determine if he was missing in 1865 through 1868 because he was deceased. If the family stories are true, he likely died closer to 1865 than 1868.

Regardless of when or how Albert died, Janie was left alone with four children to raise. She and the children moved near her father, likely on his property, since they were listed next to him in the 1870 census.²⁷ Janie married Thomas G. Yates on 3 January 1874, and he died on 5 December 1878.²⁸ She then married Thomas K. Devault on 23 November 1879.²⁹

Devault was born on 18 June 1831 in Wilson County, Tennessee, to Henry Devault and Sallie Jackson.³⁰ He married Nancy Garrett Morris on 17 October 1864 in Wilson County, and they had one son, Albert Ross.³¹ Thomas and Nancy lived in Logan County, Kentucky, in 1870, but divorced before Thomas married Janie in 1879.³² By 1880, Nancy and Albert, had returned to Wilson County to live with a son from her first marriage.³³

Janie's four children were adults by the time she and Thomas adopted Bessie Walker about 1887. Bessie and her twin sister, Jessie, were born on 15 March 1884, the children of John Lewis Walker and Nancy E. Price. Nancy died of childbirth complications a few days after the twins' birth, and John died three years later.³⁴ Janie's half-sister, Virginia, and her husband, William Henry Moore, adopted Jessie.³⁵

In February 1892, Janie's father divided up his property in the Grapevine area of Hopkins County between his four living children. Each transaction was for "love and affection" plus \$5. John kept a lifetime estate in each property for him and his wife. Janie received twenty-seven and a half acres, which her children sold to her brother Thomas for \$1100 after her death. Thomas had also received twenty-seven and a half acres from their father. Half siblings Virginia and Emsley received seventy acres and forty acres, respectively.

In 1900, Janie and Thomas lived on Robinson Street in Earlington. That census record shows Thomas owned the property, signified as a farm. However, only two deeds convey property on Robinson Street to Thomas or Janie. Both were made on 20 March 1905 and neither were for a farm. Thomas paid St. Bernard Mining Company \$75 for lot number eight in block forty-one on Robinson Street. The lot fronted fifty feet on Robinson Street and ran back one hundred ninety feet making a rectangular plot 50 feet x 190 feet. This deed was filed on 27 July 1905. Janie paid St. Bernard Mining Company \$150 for lot number twelve in block forty-three on Robinson Street. This lot also fronted fifty feet and ran back one hundred ninety feet. This deed was not recorded until 23 April 1907 when her heirs sold the property.

Janie was sixty-seven years old when she died of malaria on 23 July 1905 in Earlington.⁴³ She was buried the next day in Grapevine Cemetery, where her father, paternal grandparents, and many other relatives were buried.⁴⁴

After Janie's death, Thomas went to live with his son, Albert, in Benton County, Tennessee.⁴⁵ He died there of congestion and heart palpitations on 6 September 1918.⁴⁶ He was probably buried by Janie in Grapevine Cemetery. They have a joint headstone, which includes his name (T. K. Devault) and birthdate, but not his death date.⁴⁷ His death certificate gives his place of burial as Earlington, Kentucky, but no specific cemetery.⁴⁸ Grapevine Cemetery is about four miles from Earlington.

John Houston Hankins

John Houston Hankins was named for his grandfathers, John Emerson Goodloe and Houston G. Hankins.¹ He was born in Hopkins County, Kentucky, on 24 August, probably in 1856, the first of Albert Elvie Hankins and Isabella Jane Goodloe's four children.² Albert died when John and his siblings were children.³

John married Martha Elizabeth "Mattie" Clements on 20 November 1879 in Hopkins County. Mattie, daughter of James A. Clements and Mary Jane Christian, was born in April 1859 in Tennessee.⁵ Her nephew, Henry Thomas Clements, married John's sister, Mollie.⁶

In 1880, John and Mattie lived in the Fisherspring District in Hopkins County. Mattie's mother lived with them.⁷

John and Mattie had three sons and two daughters. Thomas was born in October 1880, probably in Hopkins County. Julia, who went by Jackie, was born on 3 May 1882 in Providence in Webster County, Kentucky.9 Hustler was born about 1891 and died on 28 February 1897 of measles and whooping cough.10 Georgia was born on 16 February 1893.¹¹ Goldie was born in August 1895.¹² The three youngest children were born in either Hopkins or Webster County.

John served as a deputy during part of R. B. Tapp's term as Hopkins County Sheriff, which ran from January 1891 to January 1895. Prior to that, John was the constable for the Dalton district for several years. 13 Sheriff Will Thompson named John his chief deputy when he took office in January 1895 and John served in that position for Thompson's three-year term.¹⁴

In early February 1897, John announced his candidacy for sheriff in that year's election. An article in The Hustler described him as well and favorably known to most of the county voters and well qualified to discharge the duties of the office.¹⁵ John won the Democratic primary in August, defeating seven other candidates. He received 787 votes and his nearest competitor received 654. John faced the Republican candidate, George R. Lynn, in the 2 November general election and won by a vote count of 2683 to 1938.¹⁷

The family lived in the Kitchen District in Hopkins County in 1900. John was still sheriff at that time, but later bought Phoenix Mills in Providence and moved there. 18 The mill manufactured high-grade flour and feed of all kinds.¹⁹

John died of smallpox on 10 June 1938 in Providence.²⁰ He had been in ill health for some time and was hospitalized in Evansville, Indiana, several weeks before contracting smallpox.²¹ He was buried in Odd Fellows Cemetery in Madisonville in Hopkins County.²²

Mattie also contracted smallpox in June 1938, but she survived it.²³ Mattie married Jesse DePriest on 12 September 1939 in Webster County.²⁴ He died on 5 January 1940.²⁵ Mattie then married Henry Shade on 26 August 1940 in Webster County.²⁶ Mattie died on 26 December 1945 at her home in Providence. She was buried in Odd Fellows Cemetery in Madisonville.²⁷

James W. Hankins

James W. Hankins was born on 25 July 1860 in Hopkins County, Kentucky. He was the third child born to Albert Elvie Hankins and Isabella Jane Goodloe.² Albert died when Jim and his siblings were children.³

In 1880, Jim lived in Hopkins County with his uncle Thomas H. Goodloe. He worked as a farm laborer.⁴ Jim worked as a miner when he married Mary J. Combs on 6 April 1883. His stepfather, T. K. Devault, served as surety on their marriage bond. They were married at the home of bride's father, who is unnamed in the record. Mary was fifteen years old and was born in Kentucky. Both of her parents were born in Tennessee.⁵ Nothing further has been found about Mary or her family, and her fate is unknown.

On 1 August 1889, Jim married Almeda Smith in Hopkins County.⁶ Medie was the daughter of Henry Clay Smith and Martha Howton. She was born on 6 January 1861 in Kentucky, probably Hopkins County.⁷

Medie previously married L. E. Egbert on 15 August 1883 in Hopkins County. They had a son named Edgar H., who was born on 15 June 1887.9 After his mother's marriage to Jim, Edgar went by Hankins for the rest of his life, but it is unclear if Jim formally adopted him.¹⁰

Jim and Medie's only child, Aggie A., was born on 9 July 1892 in Earlington in Hopkins County. 11 The family lived on Robinson Street in Earlington in 1900 near his mother and stepfather, Janie and Thomas Devault. Jim worked as a coal miner.¹² Jim and Medie lived on Robinson Street in 1910 and 1920 and Jim continued working as a coal miner.¹³

Medie died on 20 December 1927 in Earlington of chronic endocarditis. She was buried in Grapevine Cemetery in Hopkins County.¹⁴

Jim still lived in Earlington and worked as a miner when he married Lydia M. Allen Byrum on 25 April 1929. They married in Princeton in Caldwell County, Kentucky. Lydia lived in Providence in nearby Webster County, and Jim moved there after the wedding.¹⁵

Lydia was born on 25 December 1873 in Webster County, Kentucky, to Robert Allen and Nancy Jane Pearson. 16 She was the widow of Joseph O. Byrum. 17

On 15 March 1930, Jim committed suicide at his home in Providence. 18 He lived several hours after shooting himself in the head with a shotgun by using a toe to pull the trigger. The Messenger reported Jim had been in ill health for some time, but domestic trouble was the reason for his action. 19 He was buried in Grapevine Cemetery.²⁰

Lydia died in 1942 and was buried by her first husband in Pleasant Valley Cemetery in Providence.²¹

Mary Madore Hankins

Mary Madore Hankins was the fourth and last child born to Albert Elvie Hankins and Isabella Jane Goodloe. She was born on 10 March 1863 in Hopkins County, Kentucky, and was called Mollie. Albert died when Mollie and her siblings were young children.³

Mollie married Henry Thomas Clements on 8 December 1885 at her Uncle Thomas H. Goodloe's home in Hopkins County. Thomas and his wife, Mattie, served as witnesses to the ceremony.⁴ Henry was born on 9 July 1863 in Tennessee to James Thomas Clements and Martha Ann Devault.⁵

Mollie and Henry lived in Hopkins County for the rest of their lives. They had one child, a daughter named Zadie Ann. Zadie was born on 11 January 1891 in Hopkins County.⁶

In 1900, Mollie and Henry lived on Robinson Street in Earlington near her mother, her brother Jim, and Henry's parents. By 1920, they lived on Earlington and St. Charles Road. Henry worked in the coal mines for years but later changed occupations to farming.9

Mollie died on 7 February 1939 at their home, which was a mile and a half west of Earlington on Dawson Springs Road. A paralytic stroke caused her death. Her funeral was conducted at the Grapevine Church and she was buried in Grapevine Cemetery. 10

At the time of Mollie's death, Zadie and her family lived across the road from Mollie and Henry, and he lived with them in 1940.11 Henry died at Zadie's home on 5 December 1940 and his funeral was conducted there on 7 December.¹² Henry was buried by Mollie in Grapevine Cemetery.¹³

Bessie Walker Devault

Bessie Walker and her twin sister, Jessie, were born on 15 March 1884 in Hopkins County, Kentucky, the children of John Lewis Walker and Nancy E. Price. Nancy died of childbirth complications a few days after the twins' birth. With the help of his mother, John took care of the children until he died three years later.¹ The twins were adopted by Goodloe half-sisters, Janie and Virginia. Janie and her third husband, Thomas K. Devault, adopted Bessie. Virginia and her husband, William Henry Moore, adopted Jessie.²

Bessie was listed with the last name Devault in Janie's obituary in 1905 but appears to have gone by Walker most of the time. Sometime between 1905 and 1910, Bessie suffered brain damage from either an illness or accident and spent the rest of her life institutionalized.³ In 1920, 1930, and 1940 censuses, Bessie was a patient at Western State Hospital in Hopkinsville, Christian County, Kentucky.⁴ The hospital was a psychiatric facility operated by the Commonwealth of Kentucky.

On 4 September 1959, Bessie died of a coronary occlusion at Kentucky State Hospital in Danville, Boyle County, Kentucky. Her body was donated to the University of Louisville Medical School in Louisville, Kentucky.⁵
