John R. Petty and Margaret E. Thomas

John R. Petty married Margaret E. Thomas on 20 September 1857 in Whitfield County, Georgia, although neither of them likely lived there. Margaret's parents, Jesse Thomas and Rebecca Baker, lived in Murray or Lumpkin County in Georgia. John R.'s father, John Petty, lived in Bradley County, Tennessee.

Margaret was born about 1836 in Georgia.⁴ In 1840 and 1860, her family lived in Murray County, Georgia, which borders Whitfield County to the east.⁵ They lived in Lumpkin County, Georgia, two counties east of Murray, in 1850.⁶ Margaret's siblings were Mary, William, Nancy A., Oliver P., and Daniel W.⁷ Based on apparent children in Jesse's 1840 U.S. census record, Margaret may have had another brother and two other sisters.⁸

John R. was born about 1835 in Tennessee.⁹ His mother is unknown, but DNA evidence points to a maiden name of Rose.¹⁰ John R. had nine siblings, and he was the oldest son.¹¹ The youngest child was born in February 1851.¹² The family has not been found in the 1850 U.S. census when the unknown wife of the elder John should have been with him and the children.¹³ John R.'s siblings were Caroline, Charlotte, Martha J., Rash P., James, Joseph A., Angeline, Mary Elizabeth, and one unidentified sister who was one of the older children.¹⁴

John R.'s middle name may have been Rubin. His grandson Luther Petty, son of Daniel, gave Rubin Petty as the name of Daniel's father on his death certificate. No other record indicating his middle name has been found.

John R. and Margaret's first two children—Melissa A. (born abt. 1858) and Henry Milton (born 1860)—were born in Tennessee, likely in McMinn County where they lived in 1860. That census reports John R. as a renter whose personal estate was valued at \$200. He had no real estate and was not listed on the 1860 census agriculture schedule. 17

They moved to Dalton in Whitfield County, Georgia, before their third child, Samantha Angeline, was born in April 1861. Two more children were born while they lived in Dalton—Mary E. in 1865 and Daniel B. in 1867. 19

Between 1867 and 1869, John R. and Margaret moved to Logan County, Kentucky.²⁴ It is possible they moved back to Tennessee from Dalton for a short time before the move to Kentucky.²⁵

Their son Joseph Bunyan, born in 1869, was likely born in Logan County. They lived in the Keysburg District at the time of the 1870 U.S. census. John R.'s occupation was listed as farmer, but he owned no real

estate. His personal estate was valued at \$150.26 Logan County tax lists for the period he was there only exist for 1869 and he was not listed.²⁷

Margaret's mother, Rebecca Thomas, also moved to Logan County and lived nearby with her son, Daniel, and two grandsons--Mary's son, John Echols, and one of William's sons James Thomas.²⁸ John R.'s brother Joseph married Margaret's sister Nancy in Logan County in June 1869.²⁹ John R. and Margaret's son Oliver Perry was born in Logan County in 1871.³⁰

John R. and Margaret moved to Hopkins County, Kentucky, after Perry's birth and before Nathaniel was born in Madisonville in 1873.31 Their youngest two children, John Franklin and W. O., were born in Hopkins County in 1874 and 1876.³²

As with the other locations where they lived, John R. did not own property in Hopkins County.³³ He appears on the tax list in 1875, showing he owned two horses/mares, two cattle, and had 400 bushels of corn.34 He was not on the Hopkins County tax lists for 1870–1874 and their lists for 1876–1878 do not survive.35

Their infant son W. O. died on 30 June 1876 after living less than a month. 36 Margaret died a few weeks later on 28 July 1876 from complications of his birth.³⁷ Margaret and W. O. died in Hopkins County, but their burial locations are unknown.

It is unclear if John R. still lived with Margaret and the children when she died. According to family stories, he was an alcoholic and possibly abandoned the family even before Margaret and their youngest child died.³⁸ Margaret's sister Mary took five of the six youngest children (Mary, Daniel, Joseph, Nathaniel, and John) to live with her in Forsyth County, Georgia.³⁹ Perry also lived in Forsyth County but with an unrelated couple named Tribble.⁴⁰ Samantha and Henry Milton remained in Hopkins County.⁴¹ Melissa's whereabouts are unknown.

Whether John R. left before or after Margaret died, he had returned to Whitfield County, Georgia, where his father and three of his sisters lived, by 1878.⁴² He married Mary C. Bohannan there on 26 April 1878.⁴³

Mary, the daughter of Thomas Bohannan of Whitfield County, was born about 1852.44 When she married John R., she had a four-year-old son named James Charles Bohannan from an earlier relationship. 45

John R. and Mary had one son, Benjamin W., born in 1879 in Georgia, probably in Whitfield County. 46 By 1880, Mary, Benjamin, and Mary's older son lived with her father, Thomas Bohannan, in Whitfield County. John R. may have died by then although Mary's marital status of widow does not rule out him living elsewhere.⁴⁷ Mary married William Hall on 11 December 1886 in Whitfield County.⁴⁸

No further records for John R. have been found. The details of his death and burial are unknown.

Melissa A. Petty

The fate of Melissa A. Petty is unknown. She was the oldest of John R. Petty and Margaret E. Thomas's ten children, born about 1858 in Tennessee. In 1860, two-year-old Melissa lived with her parents and threemonth-old brother in McMinn County, Tennessee. 1 By 1870, the family lived in Logan County, Kentucky, and had grown to include four more children. Melissa's age was listed as eleven.2 Those two census records are the only records found to date identifying Melissa.

The six youngest children moved to Forsyth County, Georgia, after Margaret's death in 1876.³ Milton and Samantha remained in Hopkins County, Kentucky.⁴ Melissa's whereabouts are unknown.

A newspaper article published around 1934 and Samantha's obituary in 1944 both give clues about Melissa, although they conflict. The article was about brothers John and Perry reuniting after forty-four years apart. It states John returned to Madisonville, Kentucky, from Georgia to live with "his oldest sister, Mrs. S. A. Hankins, who is now 73 years of age." But Melissa was the oldest sister. That implies Melissa died before publication of this article or even before John returned to Kentucky. Samantha's obituary contradicts that theory.

Samantha's obituary says, "Mrs. Hankins was the last one of her immediate family. Three brothers and a sister have died in the last fifteen months." Samantha died on 7 January 1944, making the last fifteen months October 1942 through January 1944. Brothers Daniel, Joseph, and W. O. died well before 1942. But brothers Perry, John, and Nathaniel died during that 1942 to 1944 timeframe, making the "three brothers" part of that statement accurate. Samantha only had two sisters—Melissa and Mary. Mary died in 1891, leaving Melissa as the only possibility for a sister dying in the previous fifteen months.¹¹

Henry Milton Petty

Henry Milton Petty was born on 3 April 1860 in Tennessee, probably in McMinn County. He was the second child born to John R. Petty and Margaret E. Thomas.² Milton was sixteen years old when his mother died on 28 July 1876.³ He apparently remained in Hopkins County, Kentucky, when most of his siblings went to Georgia to live. It is unclear where or with whom he and his sister Samantha lived the first few years after their mother's death. By 1880, Milton was listed as an inmate of the Poor House in Hopkins County.5

Milton died on 9 April 1893, probably in Hopkins County. His burial location is unknown.

Mary E. Petty

Mary E. Petty, called Mollie, was born in 1865 in Georgia, probably Whitfield County. She was the fourth child born to John R. Petty and Margaret E. Thomas.² Mollie was one of the children who went to live in Forsyth County, Georgia, after Margaret died in 1876. She lived with her aunt Mary Thomas Echols and her husband.3

Mollie married Benjamin Hill Hawkins on 4 December 1881 in Forsyth County. They had five children, all likely born in Forsyth County. Robert Lee was born in 1882.⁵ Henry Grady was born on 1 April 1884.⁶ Bertha Bell was born in January 1886. Velvie Estell was born on 29 February 1888. Annie Lorena was born in July 1890.9

Mollie died in 1891, less than ten years after she married Benjamin and while her children were young. She was buried in Friendship Cemetery in Forsyth County. 10 Benjamin died on 20 December 1938 in Atlanta, Fulton County, Georgia and was buried beside Mollie.¹¹

Daniel B. Petty

Daniel B. Petty was born on 4 April 1867 in Georgia, probably Whitfield County, to John R. Petty and Margaret E. Thomas.¹ He was one of the five children who went to live with their aunt, Mary Thomas Echols and her family, in Forsyth County, Georgia, after Margaret died in 1876.²

Daniel's middle name is in question. Most researchers have it as Boone, but the source of that name seems to be "other family members." His son Luther, who provided the personal information for Daniel's death certificate, gave his middle name as Bivins.³ It is unclear which (if either) is correct.

Daniel married Mary Rebecca Cornelison, daughter of James Wilborn Cornelison and Elizabeth Owens, about 1889.⁴ They began their marriage in Cherokee County, where Mollie grew up. and lived there until after 1910. In 1900, Daniel rented land to farm and he worked in retail in 1910.⁵ All seven of their children were born during that time. Milton Perry was born on 6 September 1890,⁶ Sally O. in November 1891,⁷ Ruth V. on 12 August 1894,⁸ Luther John on 24 October 1899,⁹ Annie Estell on 23 March 1902,¹⁰ Olin Delma on 4 January 1906,¹¹ and Leland Clifford on 15 June 1908.¹²

Daniel moved the family to Cobb County, Georgia, by 1920 where he returned to farming.¹³ By 1930, they lived in Fulton County, Georgia, and Daniel worked as a carpenter building houses.¹⁴ Daniel and Mollie lived in Fulton County for remainder of their lives.

Daniel died on 26 November 1932 in Fulton County. He was buried in Hopewell Baptist Church Cemetery in Ball Ground in Cherokee County. Mary died in Fulton County on 6 December 1953 and was buried beside Daniel. 6

Joseph Bunyan Petty

Joseph Bunyan Petty was born on 20 April 1869, probably in Logan County, Kentucky. He was the sixth of John R. Petty and Margaret E. Thomas's ten children.² Joe was one of the five children who went to live with their aunt, Mary Thomas Echols and her family, in Forsyth County, Georgia, after Margaret died in $1876.^{3}$

Joe married Fredonia Tyson, called Donnie, on 12 November 1893 in Cherokee County, Georgia.⁴ Donnie was the daughter of Summerfield Francis Tyson and Mary Ann Tippens of Cherokee County. She was born there on 6 October 1878.⁵

In 1900, Joe and Donnie lived in Canton, Cherokee County, Georgia, with their three oldest children.⁶ John Wesley was born on 6 August 1894, Cora L. in June 1896, and Mamie in May 1897. By 1910, they had moved to Muhlenberg County, Kentucky, and lived in the community of North Boggess. Five more children were born since 1900, all in Georgia before the move to Kentucky.8 Joseph Earl was born on 1 July 1900 in Bartow County, Corrie Jean in 1902, Jackson Buford on 17 June 1904 in Cherokee County, Clyde E. in 1908, 12 and Oscar Milton on 24 April 1908 in Gordon County. 13

Their son Emmett Lee gave his birthdate and place as 22 April 1910, Louisville, Kentucky, when he registered for the World War II draft.¹⁴ He was not listed with the family in the 1910 census in Muhlenberg County, but the census date of 15 April would have precluded him being counted.¹⁵ Emmett's birthplace was listed as Georgia in the 1920 census. 16 If Emmett was born in Louisville, the family lived in Muhlenberg County less than three weeks later.¹⁷

They were back in Georgia before the last four children were born and apparently moved back and forth between Gordon and Bartow counties. Grace Mae, who was born about 1912, was probably born in one of those two counties.¹⁸ A. Z. was born on 6 August 1915 in Gordon County.¹⁹ Wilson was born in Bartow County on 8 May 1916.²⁰ They were still living in Bartow County in 1920 and their youngest child, Doyle Asberry, was born there on 1 July 1920.²¹ They moved back to Gordon County between 1920 and 1924 when Grace died at their home there on 15 February 1924.²²

When they returned to Georgia, Joe became a farmer.²³ He had worked as a coal miner prior to that.²⁴ Joe and Donnie divorced after 1920, and she married Joe Anderson before 15 April 1930.²⁵

Joe died of hypertensive heart disease on 10 April 1937 in Atlanta, Fulton County, Georgia. 26 Donnie died on 22 November 1941 in Calhoun, Gordon County, Georgia.²⁷ They are buried together in Scott Cemetery in Plainville, Gordon County, Georgia.²⁸

Oliver Perry Petty

Oliver Perry Petty was born on 23 January 1871 in Logan County, Kentucky.¹ He was the seventh child born to John R. Petty and Margaret E. Thomas.²

Perry was one of the six children who went to Forsyth County, Georgia, to live after Margaret's death in 1876. The other five children lived with their aunt Mary Thomas Echols.³ Perry lived with James W. and Angeline Tribble in 1880 with the relationship of adopted son in that census.⁴ It is unclear if this was a legal adoption or if the Tribbles simply took him in. While his surname name in that census was Tribble, no evidence exists that he ever went by anything other than Petty for the rest of his life. The reason Perry lived with the Tribbles, rather than with his aunt Mary and siblings, is unknown. But he apparently had a long-term relationship with them. After the death of Perry's first wife, his son Elmer lived with the Tribbles in 1900.⁵

On 28 August 1890, Perry married Vada L. Bramlett in Forsyth County, Georgia.⁶ Vada was born on 13 April 1875 in Georgia, probably Forsyth County.⁷ James A. Bramlett and Armenda Redd were her parents.⁸

Perry and Vada had a daughter and three sons born between 1891 and 1898. Odell was born about 1891, probably in Forsyth County. Elmer Washington was born on 10 September 1894 in Forsyth County. Daniel Paul was born on 15 December 1895 in Cherokee County. Claud was born on 6 August 1898, probably in Cherokee County. Vada died on 9 August 1899 and was buried in Friendship Cemetery in Forsyth County.

In 1900, Perry boarded with Fred Phillips in Pickens County, Georgia, and worked as a house carpenter.¹⁴ Paul and Claud lived with Vada's parents in Forsyth County and Elmer lived there with the Tribbles.¹⁵ Odell's whereabouts are unknown.

Eliza Duckett also lived in Pickens County in 1900 and worked as a cook in a boarding house run by Mason Fowler.¹⁶ Perry married Eliza between 1900 and 1903.¹⁷ Eliza was born on 18 February 1873 in Georgia to Jacob B. Duckett and Sarah J. Thomas.¹⁸

Perry and Eliza lived in Pickens County in 1910 with their children Oliver, Edward, Eula, and Jennie Mae, along with Perry's sons Paul and Claud.¹⁹ Oliver Cicero was born on 19 June 1903 in Tate in Pickens County.²⁰ James Edward was born on 9 July 1905.²¹ Eula Mae was born on 28 October 1907.²² Jennie Mae was born on 8 July 1909.²³ Edward, Eula, and Jennie were probably all born in Picken County.

By 1920, the family lived in Fullers in Cobb County, Georgia, and two more children had been born.²⁴ Lou Vada was born on 27 December 1911 and Joe Dorsey was born on 6 July 1915.²⁵ Joe was born in Cobb County and Lou Vada likely was as well.²⁶

Between 1920 and 1929, Perry and Eliza moved to Atlanta in Fulton County, Georgia. They lived on Rt. 7 in Atlanta when Eliza died on 22 September 1929 of an intestinal obstruction.²⁷ She was buried in Marietta City Cemetery in Marietta, Cobb County, Georgia.²⁸

In 1930, Perry and four of the children (Edward, Eula, Lou Vada, and Joe) lived on St. James Drive in Center Hill in Fulton County. Perry had changed occupations from farming, which he was doing in 1910 and 1920, back to carpentry.²⁹

Perry took a trip to Madisonville, Kentucky, around 1934 to visit his sister Samantha. While in the area, he and Samantha also visited their brother John Franklin in Harrisburg, Illinois. According to an undated

newspaper clipping saved by John's family, it had been forty-four years since the brothers had seen each other. Using Samantha's age noted in the article, forty-four years ago would have been about 1890.³⁰

Perry died on 5 February 1943 at his home at 539 Luckie Street in Atlanta. He had been a building contractor for the past eighteen years.³¹ Perry was buried beside Eliza in Marietta City Cemetery.³²

Nathaniel T. Petty

Nathaniel T. Petty was born in 1873. He gave his birth date as 22 January 1873 when he registered for the World War I draft on 12 September 1918.¹ That form does not include a birth place. When he applied for a Social Security number, Nath gave his birth date as 21 February 1873 and his birthplace as Madisonville, Tennessee.² Since the family lived in either Logan or Hopkins County, Kentucky at that time, his birthplace was Madisonville, Kentucky, which is in Hopkins County.³ His correct birth date is unknown.

Nath was three and a half years old when his mother died in July 1876.⁴ He was one of the five children who went to live with their aunt Mary Thomas Echols in Forsyth County, Georgia, after Margaret died.⁵

On 12 May 1906, Nath married Delia Harmon in Cherokee County, Georgia.⁶ Delia was born on 11 February 1887 in Georgia.⁷ Her parents were James Matison Harmon and Emaline Bennett.⁸

By 1910, Nath and Delia lived on Lowe Avenue in Collins District in Fulton County, Georgia, and Nath worked as an engineer on the railroad. They had two children. Alma was born on 10 March 1907. Emmett was born on 17 March 1909. Both children were born in Georgia, probably in Cherokee or Fulton County.

Delia died on 23 June 1914 at their home in Peachtree Park area of Atlanta in Fulton County. ¹³ She was buried in Pleasant Hill Christian Church Cemetery in Cagle, Pickens County, Georgia. ¹⁴

Nath married Amanda Kincaid about 1915.¹⁵ Amanda was born on 20 June 1896 in Fannin County, Georgia.¹⁶ Her parents were Calvin Kincaid and Pairlee Lands.¹⁷

Nath and Amanda's son Clifford gave his birthplace as Copperhill, Tennessee, which is in Polk County, when he applied for a Social Security number. He said he was born in Fannin County, Georgia when he registered for the World War II draft. Amanda's parents lived in Sugar Creek in Fannin County, which borders Polk County and is fourteen miles from Copperhill. Clifford was also inconsistent about his birth year giving the date as 22 January 1916 to Social Security and 22 January 1917 on his draft registration.

When Nath registered for the World War I draft on 12 September 1918, they lived in Etowah, McMinn County, Tennessee.²² Geneva Harriet was born on 22 June 1919 in Cooperhill.²³

In 1920, Nath and Amanda lived in Fairplay in Cherokee County, Georgia, and he farmed.²⁴ They apparently soon moved as Pauline was born on 2 November 1921 in Whitestone in Gilmer County, Georgia.²⁵

The family lived in Town Creek in Gilmer County in 1930, but it is possible they moved between 1921 and 1928 and then returned to Gilmer County. ²⁶ Dorothy was born about 1924 in either Tennessee or Georgia, but the exact location is unknown. ²⁷ John William was born on 23 February 1926 in Copperhill, Tennessee. ²⁸ Annie Mae was born on 18 November 1928 in Gilmer County. ²⁹ In 1930, Nath worked as a fireman in a dolomite mine. ³⁰

Nath and Amanda moved to Pickens County, Georgia, by the time their youngest child, Bertha Neel, was born there on 10 August 1933.³¹ Amanda died on 30 June 1936 in Ball Ground in Cherokee County where they lived since at least 1935.³² She was buried in Four Mile Baptist Church Cemetery in Pickens County.³³

Nath lived in the Dug Road District in Pickens County in 1940 and was again farming. The six youngest of his and Amanda's seven children lived with him.³⁴

On 30 October 1942, Nath died in Pickens County.³⁵ He was buried beside Amanda in Four Mile Baptist Church Cemetery.³⁶

John Franklin Petty

John Franklin Petty was twenty-two months old when his mother died in 1876.¹ He was born on 15 September 1874 in Hopkins County, Kentucky, to John R. Petty and Margaret E. Thomas.² John was one of the five children who went to live with their aunt Mary Thomas Echols in Forsyth County, Georgia, after Margaret's death.³ He returned to Hopkins County as a teenager to live with his sister Samantha.⁴

John married Elizabeth Jane Givens at her parents' home in Hopkins County on 24 February 1897.⁵ Lizzie was born on 3 November 1878, probably in Hopkins County, where she and her parents lived in 1880.⁶ Her parents were John Lewis Givens and Cecil L. Trigg.⁷

Their first child, Curtis Lyle, was born on 20 May 1898 in Princeton, Caldwell County, Kentucky.⁸ John, Lizzie, and Curtis lived in Hopkins County in 1900 where John worked as a coal miner.⁹

John and Lizzie's only daughter, Lora, was born on 14 June 1901 and died on 22 September 1902. They probably lived in Muhlenberg County then since Lora was buried in Eaves Cemetery at Powderly. They apparently moved to Illinois after Lora's death. Their youngest son, Frank Givens, was born on 17 June 1903 in Marion, Williamson County, Illinois. 11

By 1910, John, Lizzie, and the boys were back in Muhlenberg County and lived on Depot Street in Greenville. John continued working as a coal miner.¹²

John and Lizzie next moved to Harrisburg, in Saline County, Illinois, where they lived for the rest of their lives. On 12 September 1918, they lived at 100 E. Walnut Street. John worked for O'Gara Coal Company as a miner. In 1920, their address was 306 N. Vine Street, but it is possible they had not moved. Under the Corner of Walnut and Vine and Google Maps identifies both addresses as the same house.

In 1927, they lived at 200 E. Dayton Avenue. John had switched occupations from coal mining to salesman. ¹⁵ By 1930, they lived at 402 Ford Avenue, and John worked for an electrical supply company as a sales. ¹⁶

John's brother Perry took a trip from Georgia to Madisonville, Kentucky, around 1934 to visit their sister Samantha. While in the area, he and Samantha also visited John in Harrisburg. According to an undated newspaper clipping saved by John's family, it had been forty-four years since the brothers had seen each other. Using Samantha's age noted in the article, forty-four years ago would have been about 1890.¹⁷

John died on 30 June 1943 in Harrisburg. He was buried there in Sunset Lawn Cemetery. Lizzie died in Harrisburg on 22 March 1967 and was buried beside John. 20

W. O. Petty

W. O. Petty was the last child born to John R. Petty and Margaret E. Thomas. He appears to have two different birth records with different dates and names. One record is for W. O. Petty, born on 5 June 1876.1 The other is for Osker L. Petty, born on 28 June 1876.2 Both births are recorded in Hopkins County, Kentucky. The 5 June entry for W. O. lists his parents as J. R. Petty (born in Tennessee) and M. E. Thomas (born in Georgia).³ The 28 June entry for Osker L. lists parents Jno R. Petty (born in Tennessee) and M. E. Thomison (born in Georgia).4

Clearly, Margaret did not give birth to two children twenty-five days apart. Whichever date is correct, the child lived no longer than a few weeks or a few days. He died in Hopkins County on 30 June 1876. His death record gives his age as three weeks, making the 5 June birthdate most likely. It is unclear which name is correct, but the death record also gives his name as W. O.5 The cause of his death and his burial location are unknown. Margaret died less than a month later from complications from his birth listed as "woomb disease" on her death record.6

Benjamin W. Petty

Sometime around 1876, John R. Petty returned to Whitfield County, Georgia, where his father, John Petty, and three of his sisters lived. He married Mary C. Bohannan there on 26 April 1878.¹

Mary, the daughter of Thomas Bohannan, was born on 12 September 1851 in Georgia.² John R. and Mary had one son, Benjamin W. Petty. He was born on 24 February 1879 in Georgia, probably in Whitfield County.³ It is unknown if Ben was aware that he had Petty half-siblings or if any of John R.'s other children were aware of Ben.

By 1880, Mary and her two sons (one from a previous relationship) were living with her father. John R. was not with them, and Mary was listed as widowed.⁴ When John R. died is unknown, but their marriage record is the last record found for him.

Mary married William Hall on 11 December 1886 in Whitfield County.⁵ By 1900, they lived in Bradley County, Tennessee.⁶

Ben married Maud Alice Collins in Meigs County, Tennessee on 21 February 1900.⁷ Maud was born on 25 November 1882 and was the daughter of James B. Collins and Mary J. Gross.⁸ Their location in 1900 is unknown, but Ben and Maud lived somewhere in Tennessee when their first child, James Clifford, was born on 4 August 1903.⁹

Ben and Maud's son Charles Raymond was born on 3 June 1909 in Cleveland in Bradley County. ¹⁰ Ben, Maud, and the two boys lived in Bradley County in 1910 and Ben farmed on rented land. ¹¹ Their daughter, Leora, was born on 29 April 1914 in Georgetown, Tennessee. ¹² Georgetown is at the junction of Bradley, Hamilton, and Meigs counties.

On 21 May 1917, Ben died in Cleveland. Bright's disease caused his death.¹³ He was buried in Flint Springs Cemetery in Cleveland.¹⁴ Maud died on 26 November 1938 in Chattanooga, Hamilton County, Tennessee.¹⁵ She was buried in Greenwood Cemetery in Chattanooga.¹⁶
